

TERMS & CONDITIONS OF USE OF WEBSITE

These Terms and Conditions of Use (the “**Terms of Use**”) apply to the website located at URL www.lexplanit.com (“**Site**”). The Site is the property of Aleos Solutions and Services Private Limited (“**Aleos**”) and its licensors (if any). BY USING THE SITE, YOU AGREE TO THESE TERMS OF USE; IF YOU DO NOT AGREE, DO NOT USE THE SITE.

Aleos reserves the right, at its sole discretion, to change, modify, add or remove portions of these Terms of Use, at any time. It is your responsibility to check these Terms of Use periodically for changes. Your continued use of the Site following the posting of changes will mean that you accept and agree to the changes. As long as you comply with these Terms of Use, Aleos grants you a personal, non-exclusive, non-transferable, limited privilege to enter and use the Site.

1. Content

- 1.1. All text, graphics, user interfaces, visual interfaces, trademarks, logos, sounds, music, artwork and computer code or downloadable software programs (collectively, “**Content**”), including but not limited to the design, structure, selection, coordination, expression, “look and feel” and arrangement of such Content, contained on the Site is owned, controlled or licensed by or to Aleos and is protected by copyright, patent and trademark laws, and various other intellectual property rights and unfair competition laws, as may be applicable.
- 1.2. Except as expressly provided in these Terms of Use, no part of the Site and no Content may be copied, reproduced, republished, uploaded, posted, publicly displayed, encoded, translated, transmitted or distributed in any way (including “mirroring”) to any other computer, server, website or other medium for publication or distribution or for any commercial enterprise, without the express prior written consent of Aleos.
- 1.3. You may use information on Aleos’ products and services (such as data sheets, knowledge base articles, and similar materials) made available by Aleos for downloading from the Site, provided that you (1) do not remove any proprietary notice language in all copies of such documents, (2) use such information only for your personal, non-commercial purpose and do not copy or post such information on any networked computer or broadcast it in any media, (3) make no modifications to any such information, and (4) do not make any additional representations or warranties relating to such documents.

2. Your Use of the Site

- 2.1. 7.1. Site or any Content, Aleos's liability shall in no event exceed the greater of (1) the total of any subscription or similar fees with respect to any service or Content or feature or product of or on the Site paid in the six months prior to the date of the initial claim made against Aleos, or (2) INR 10,000/-.

9. Indemnity

You agree to indemnify and hold Aleos, its officers, directors, shareholders, predecessors, successors in interest, employees, agents, subsidiaries and affiliates, harmless from any demands, loss, liability, claims or expenses (including attorneys' fees), made against Aleos by any third party due to or arising out of or in connection with your use of the Site.

10. Violation of These Terms of Use

10.1. 10.3. You agree that Aleos may, in its sole discretion and without prior notice, terminate your access to the Site and/or block your future access to the Site if we determine that you have violated these Terms of Use or other agreements or guidelines which may be associated with your use of the Site. You also agree that any violation by you of these Terms of Use will constitute an unlawful and unfair business practice, and will cause irreparable harm to Aleos, for which monetary damages would be inadequate, and you consent to Aleos obtaining any injunctive or equitable relief that Aleos deems necessary or appropriate in such circumstances. These remedies are in addition to any other remedies Aleos may have at law or in equity.

10.4. You agree that Aleos may, in its sole discretion and without prior notice, terminate your access to the Site, for cause, which includes (but is not limited to) (1) requests by law enforcement or other government agencies, (2) a request by you (self-initiated account deletions), (3) discontinuance or material modification of the Site or any service or product or Content offered on or through the Site, or (4) unexpected technical issues or problems.

10.5. If Aleos does take any legal action against you as a result of your violation of these Terms of Use, Aleos will be entitled to recover from you, and you agree to pay, all reasonable attorneys' fees and costs of such action, in addition to any other relief granted to Aleos.

11. Governing Law; Dispute Resolution

You agree that all matters relating to your access to or use of the Site, including all disputes, will be governed by the laws of the Republic of India without regard to its conflicts of laws provisions. You agree to the exclusive jurisdiction of the competent courts of Mumbai and waive any objection to such jurisdiction or venue. In the event of any controversy or dispute between Aleos and you arising out of or in connection with your use of the Site, the parties shall attempt, promptly and in good faith, to resolve any such dispute. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation/ conciliation under the Indian Arbitration and Conciliation Act, 1986, to a mediator/ conciliator to be appointed by Aleos, whose appointment you hereby consent to. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable law.

12. Void Where Prohibited

Aleos administers and operates the Site from its location in Mumbai, India. Although the Site is accessible worldwide, not all features, products or services discussed, referenced, provided or offered through or on the Site are available to all persons or in all geographic locations, or appropriate or available for use outside India. Aleos reserves the right to limit, in its sole discretion, the provision and quantity of any feature, product or service or Content to any person or geographic area. Any offer for any feature, product or service or Content made on the Site is void where prohibited. If you choose to access the Site from outside the India, you do so on your own initiative, and you are solely responsible for complying with applicable local laws.

These Terms of Use constitute the entire agreement between you and Aleos with regard to your use of the Site, and any and all other written or oral agreements or understandings previously existing between you and Aleos with respect to such use are hereby superseded and cancelled. Aleos will not accept any counter-offers to these Terms of Use, and all such offers are hereby categorically rejected. Aleos' failure to insist on or enforce strict performance of these Terms of Use shall not be construed as a waiver by Aleos of any provision or any right it has to enforce these Terms of Use, nor shall any course of conduct between Aleos and you or any other party be deemed to modify any provision of these Terms of Use. These Terms of Use shall not be interpreted or construed to confer any rights or remedies on any third parties.

14. Feedback and Information
